THE SANTA MONICA BAY NATIONAL ESTUARY PROGRAM, SMBNEP, IS ONE OF 28 SIMILAR PROGRAMS ESTABLISHED UNDER SECTION 320 OF THE 1987 CLEAN WATER ACT AND ADMINISTERED BY THE U.S. ENVIRONMENTAL PROTECTION AGENCY, U.S. EPA. FUNDING IS PROVIDED BY THE U.S. EPA TO IMPLEMENT THE SMBNEPS COMPREHENSIVE PLAN OF ACTION, KNOWN AS THE BAY RESTORATION PLAN, BRP, TO PROTECT AND RESTORE THE SANTA MONICA BAY. THE BRP WAS APPROVED BY THE STATE OF CALIFORNIA AND THE U.S. EPA IN 1995 AND UPDATED IN 2008 AND 2013. THE BRP INCLUDES GOALS, OBJECTIVES, AND MILESTONES TO GUIDE SMBNEPS PROGRAMS AND PROJECTS IN THREE PRIORITY AREAS, WATER QUALITY, NATURAL RESOURCES, AND BENEFITS AND VALUES TO HUMANS.
